The CECSD consists of a 5-member board whose primary authority is the construction and maintenance of the CECSD roadways and easements. Board meetings occur bimonthly. Board members are paid \$80 per regular meeting. It does not cost anything to run for the position and you will be given good training if elected. To qualify you must be a registered voter living in the District. Declaration of Candidacy forms are available at the El Dorado County Elections Department beginning July 13, 2020. The forms must be filed at the Elections Department online site by August 7, 2020, before 5:00 p.m.
